Rules & Regulations

- **The Grape Stomp will be held rain or shine.** There is no rain date. You are responsible for protecting your equipment and/or merchandise from inclement weather. No refunds for weather delays or cancellations.
- **You may start set-up no earlier than 10:00 a.m. and your exhibit must be completely installed by 12 noon.** Failure to be on-site and set-up by 12:00 noon may result in a reassignment of your space. All vehicles must be out of the area by 12 noon and cannot return to the site before 4:00 p.m. Break down will commence no sooner than 4:00 p.m. and **your exhibit must be completely off the grass no later than 6:00 p.m.**
- **No special permits are available for vendor parking.** Vendor parking is available at the end of Main Street in the Vendor Parking designated area.
- **Booth numbers will be assigned when payment is received by the Grandview Chamber of Commerce.** Call 509-882-2100, if you do not receive your booth number before the event. Expect a map of the booth area with your number five days before the event (for early registration only).
- **Your paid vendor fee entitles you to a 10' x 10' space; you must provide your own table, chairs, tent, etc.** You are required to have an attendant at your space during all events hours as well as during set-up and break-down. **You must keep your display within your 10' x 10' assigned space.**
- **Your Vendor Application & Agreement required you to specify EXACTLY what items are being sold, exhibited, promoted or distributed at the event.** If, on the day of the event, you include items that were not specified in the Vendor Application & Agreement, or if you include items that are of a controversial nature, (e.g., not family-oriented), the Grandview Chamber of Commerce has the right to ask you to remove such item(s) or leave the event. You must not engage in any illegal activity of any kind.
- **No microphones or playing of music is allowed. No raffles or games of chance** will be permitted unless pre-approved by the Grandview Chamber of Commerce.
- **Food vendors must provide their own health card permits and/or temporary food service applications.** The Yakima Health District can be reached at 509-575-4040 or on their website at <http://www.yakimapublichealth.org> for information.
- **AT NO TIME may beer, wine or liquor be sold** or distributed from any booth unless specifically authorized by the Grandview Chamber of Commerce. **AT NO TIME may food or beverages be sold from a Retail booth.**
- **ANY VENDOR WHO POURS GREASE OR DISPOSES OF FOOD WASTE ON THE STREET AND/OR SIDE-WALK WILL BE FINED \$150.00.** You are required to take appropriate measures to prevent damage to streets, sidewalks and other private and public property as a result of your participation in the event, including the use of protective coverings on streets and sidewalks as necessary if food products are cooked in or produce grease. If you use or create grease, charcoal, ashes or food waste you must properly dispose of these materials. **In addition to the \$150.00 fine, you will be liable for any damages** caused by you and your employees and agents in connection with your participation in the event, including all repairs to sidewalks, streets and other property. Property damage by any vendor will result in the exclusion of that vendor from subsequent events.
- **Vendors with excessively loud generators may be moved to a less central location** within the event groups at the sole discretion of the Grandview Chamber of Commerce.
- **Do NOT leave your trash behind** or any leftover merchandise. **You must leave your space as you found it.** Any vendor violating this rule will be barred from future events. Please use trash receptacles to clean your area. All merchandise and trash left in the area after 9:00 p.m. will be removed by the Grandview Chamber of Commerce at the expense of the vendor.
- **Spaces are non-transferable.** You may not sublet your space or any portion of it.
- **Neither the Grandview Chamber of Commerce, the City of Grandview, or Yakima Valley Community College,** its directors, officers, employees, representatives, agents and volunteers are liable for any damage to or destruction of any exhibit, booth or vendor space from any cause whatsoever, or the theft or disappearance from any vendor or exhibitor.
- **You are responsible to maintain all required insurance** of whatever nature, including but not limited to, liability insurance and worker's compensation insurance, at your own expense and initiation. The Grandview Chamber of Commerce assumes no responsibility of any kind for insurance on behalf of any vendor or exhibitor.
- **You agree not to hold the Grandview Chamber of Commerce, its directors, officers, employees, representatives, agents and volunteers, responsible** for any accident or injury incurred during this event. You, yourself, your children, your heirs, executors and administrators further agree to hold the Grandview Chamber of Commerce, its directors, officers, employees, representatives, agents and volunteers, harmless from and against any and all claims, demands, damages, and actions the Grandview Chamber of Commerce, its directors, officers, employees, representatives, agents and volunteers, may sustain or incur, directly or indirectly, as a result of your actions or inaction or the actions or inactions of your employees, agents or volunteers in connection with your participation in this event.
- **Your violation of any of these rules and regulations** or of applicable law will result in the forfeiture of your space and your removal from the event. By signing the Vendor Application and Agreement, you expressly agreed to waive any right to recourse or to demand refund or to claim damages on such grounds.
- **The interpretation of any of these rules and regulations** is the sole responsibility of the Grandview Chamber of Commerce and all decisions of the Grandview Chamber of Commerce shall be final and enforceable.
